This guide is provided to bring forward awareness of every-body's status as a private individual, man or woman, acting with duty of care and due diligence with/to all others within the common laws of the people.

This is not a pathway to 'Freeman on the Land' or 'Sovereignty' or the many other guises of 'freedom'.

This is about creating a unified withdrawal of consent through a proper lawful jurisdiction which stands above all others to negate the tangible, palpable sense of futility that is being experienced as our lives become increasingly autocratic.

The resources that have been utilised to bring about this guide will be attributed to those whose shoulders i stand upon and being grateful for their diligence.

You will see the use of many words with the same meaning. As you progress you will become aware that use of the correct words are particularly important when acting or performing, or appearing within different places, courts, jurisdictions

### **Preamble**

We are all energy (spirit or soul) embodied in a physical presence existing in this realm (universe) and are 'vested' with the capacity to express free-will to choose (consent) how we function within the many realms (jurisdictions) created by other people throughout time.

Being 'free' is a mindset based on comprehension of what your status <u>is</u>, where you stand within your community and the realm in which we exist as a living soul or as your PERSON.

We are indoctrinated by our up-bringing, education, programming by the tell-a-vision and other media to believe our status is sub-servient to the controls of authority, where in reality we are the creators and masters of all we behold which is held equally with all other living souls. We are the beneficiaries of the last will and testament of all that came before us.

Authority is only given to people who swear fealty (oath) to the creators or masters and are given title to act in that role within the bounds of the common law and the legislation created to control that office on behalf of the creators or masters (public service).

First you must be aware of **who** and **what** you are and your **Status**, **Standing** and **Capacity** as a **Living Being** or **Living Soul** within the wider community of people on the land as it is known as (named).

In this guide it will mainly relate to my nation, The Kingdom of England, otherwise re-presented as Britain or England or United Kingdom or The Commonwealth, which is the foundation of the constitutions of many other nations (countries) with their given names (USA, Canada, Australia, etc).

# Who you are: the living soul

When you are born (not birthed or delivered) and take your first breath of life, your **un-a-lien-able** rights are passed onto to you by the creators, the Universe or your God or your parents, your choice.

Your parents choose your 'given' name[s] and these become inherently part of their and thereafter your 'family name'. These are not you 'first', 'middle', 'last' name or 'surname'.

For example, Joseph-Frederick of the family Bloggs or Joseph-Fredrick: Bloggs

If you have been accepted into the realm of your belief system, baptised or christened, your given names become your 'christian' names.

Within some belief structures you choose an additional name during a 'confirmation' of acceptance into that society, this is your chosen name.

Note: these formats of names are mainly determined by the Judean/Roman or Christian systems, there are other formats relevant to other belief structures

This is who you are, one of the people, a living soul, a living being, a boy or girl, a man or woman.


You are not a 'person' you have a 'person'. you are not a 'human being' or 'citizen' or 'resident' or 'civilian', etc. these are what your 'person' is

# What you are: the PERSON

When your birth is registered and then certified, your 'legal person' identity is created through what is known as unlawful conversion. This is what is used in commerce and what binds you to statutory law or civil proceedings and is referenced in ALL proceedings. This what you <u>have</u>, not <u>WHO</u>.

For example, JOSEPH FREDERICK BLOGGS or any other variation and not as per your 'given names'.



REGISTRY. A duty imposed on shipowners in order to secure to their vessels the privileges of ships of the nation to which they belong. Also called registration, documentation. Registration is made by the principal custom officer of the port chosen. It includes: name of the ship, name of owners, tonnage, build, and description of the vessel, particulars of its origin, name of the master, name of the one entitled to the custody of the certificate of registration. The vessel is considered to belong to the port at which it is registered.

In the United States three terms are used to denote the registration of vessels according to their trade and tonnage: Vessels in foreign trade are "registered."

Vessels in foreign trade are "registered." Vessels in coasting and Great Lakes trade are "enrolled."

Vessels under 20 tons (coasting trade and fisheries) are "licensed."

All are referred to as "documented."

### The Unlawful conversion

When you are 'birthed' this is registered first by the midwife using the family name 'baby BLOGGS' (in caps because that's how they are told to).

Then by your parents complete this registration providing your given names 'BLOGGS Joseph Frederick' and through this your 'birthing' becomes certified as the 'legal person' or 'legal fiction' which is a "vessel" in which the State/Government creates a security interest, via what is known as a Birth Bond. Your parents are not informed and you cannot be unaware of this.

Note: it is put forward by some that the value of this is your birth weight in gold

After 7 years if this bond becomes un-claimed it is 'salvaged' by organisations (The Treasury) and securitised as a trust and placed upon the bond market to be traded upon. You are bonded soul (bondage) or servile or if you wish a 'slave'.

Upon it reaching maturity (your legal age) you <u>should</u> become the Master of that "vessel" that has been salvaged under Admiralty Maritime jurisdiction, or the "Law of the Sea". You are unaware of this so as per the Cestui Que Vie Act 1666 'persons' are considered 'lost at sea' and can be salvaged (captured).

For examples of this, review your birth certificate, passport and driving licence (read everything in these and note the words and the numbers). Within these you are identified by your full name with at least your family name in capital letters, which is the format that <u>re-presents</u> you as the 'person'

Now go look at your council tax bill, different format of your name. Now look at all the others, HMRC, water, gas, electric, bank account, debit card, credit card, etc. You will find that most of them have your name in different formats, or syntax, even the use of different characters can be used, aA or aA.

Examples - *Mr Joseph F. Bloggs* or *Mr J. F. Bloggs* or *Mr Joseph Bloggs* or even *Mr Joseph Bloggs* <- (look at the different character type) and always using a title (Dr, Sir, Lord, HRH, Mr, Mrs, Mx, Miss, Esq, Master ...) which are owned by The Crown and which you do not have the right to use.

### Black's Law - Person

"Persons" are of two kinds, natural and artificial. A natural person is a human being. Artificial persons include a collection or succession of natural persons forming a corporation; a collection of property to which the law attributes the capacity of having rights and duties. The latter class of artificial persons is recognized only to a limited extent in our law. Examples are the estate of a bankrupt or deceased person. It has been held that when the word person is used in a legislative act, natural persons will be intended unless something appear in the context to show that it applies to artificial persons, but as a rule corporations will be considered persons within the statutes unless the intention of the legislature is manifestly to exclude them.

In other words, your 'person' is property, a fictional vessel on paper, that acts in commerce with all other 'persons' and as such the <u>rightful owner</u> can re-possess it and be the individual with 'fiduciary' responsibility for that 'body incorporate'. Note: 'corporate' is Corpse (dead) - Orate (speak) or Dead - Speak

Some consider this conversion to be a fraud or deception <u>purposely</u> brought upon the people, where in reality it is what has come about over time as a means of carrying out commerce or dealing with disputes between people (men and women) and organisations.

This may have been captured and manipulated by people with nefarious intentions but the core of what was there is still there and can be used to re-present yourself as 'living' with a status and standing correction and then re-present and administrate (control) your 'person'

#### Rule of Law

Your un-a-lien-able rights as defined by the Natural Laws, The Common Law (man-made/Case law/Maxims) and your naturalised rights as defined by the Magna Carta (constitution) and the Bill of Rights.

### Statutory 'Law'

Legislation, Statutory instruments, Acts, etc are <u>rules</u> defined by the **governance** you are **sponsoring** and requires your consent to be bound by them. They apply to the <u>person</u> and not a man or woman.

These are words laid down on paper by other men and women who have created societies, chapters, associations, forums, councils, legislators, assemblies, etc (LAW, BAR, Judiciary, etc) and give these words the 'colour of law' or de-facto and are not de-jure, which is actual law.

The only thing that gives them jurisdiction over you is your tacit consent by your use of your 'person'. You have a 'person', you are not a person, and your 'person' is what you utilise to 'do business' or contract with organisations or entities which only exist on paper, as does your 'person'

<u>Un-a-lien-able Rights</u> Personal rights held by an individual which are not bestowed by law, custom, or belief, and which cannot be taken or given away, or transferred to another person

<u>Natural Law</u> The belief that certain laws of morality are inherent by human nature, reason, or religious belief, and that they are ethically binding on humanity.

<u>Common Law</u> Laws that are based on court, or tribunal, decisions by a jury, which govern future decisions on similar cases.

The common law maxims (a general truth or fundamental principle)

Do not knowingly

- 1. Cause harm
- 2. Cause loss
- 3. Commit fraud,
- 4. Cause Damage,
- 5. Cause loss of life
- 6. Breach the peace

<u>Breach of Peace</u> We are entitled to live a peaceful coexistence and we all have an obligation to uphold the peace. An unlawful claim against someone is a **trespass** and is a breach of the peace. At the point of breaching the peace of somebody who has breached the peace, the reasonable evidence of this must be collected <u>before</u> and not after the fact.

Magna Carta Magna Carta, meaning 'The Great Charter', is one of the most famous documents in the world. Originally issued by King John of England (r. 1199–1216) as a practical solution to the political crisis he faced in 1215, Magna Carta established for the first time the principle that everybody, including the king, was subject to the law. Although nearly a third of the text was deleted or substantially rewritten within ten years, and almost all the clauses have been repealed in modern times, Magna Carta remains a cornerstone of the British constitution.

Bill of Rights The English Bill of Rights was an act signed into law in 1689 by William III and Mary II and outlined specific constitutional and civil rights and ultimately gave Parliament power over the monarchy. Many experts regard the English Bill of Rights as the primary law that set the stage for a constitutional monarchy in England

Governance This is what you sponsor when voting (a ballot) or paying your taxes, bills and licences or receiving benefits and the worst thing by giving up ownership of your property by registering/certifying it. The governance we request, operates as service organisations and entities and are PERSONS not PEOPLE.

The elected Government writes legislation, acts, ordinances, policy, codes, bylaws, etc, through statuary instruments to provide guidelines for social cohesion. There are <u>finite</u> procedures for enacting these and are subject to consent of the people, normally through parliament but primarily by each individual.

If you have not consented or <u>contracted</u> to be bound by these and they are <u>not</u> stated to apply to you by your <u>given name(s)</u> which does not include your surname or any title (Mr, Mrs,etc) then you have no obligation to follow them unless you wish to voluntarily as a duty of care and without actual consent.

Legislation, etc, can be defined as service contracts of governance between the people and the persons. Infractions, or what is <u>illegal</u>, are managed by <u>civil proceedings</u>. This is not the **Rule of Law** which stands above these and cannot come before it or change it.

#### **Contract Law**

The common maxims of a contract

- 1. Offer
- 2. Acceptance
- 3. Consideration
- 4. Full disclosure (meeting of minds)
- 5. All parties (peoples) signature or autograph


In other words, informed consent, agreement and acknowledgment. It is binding and lawful and can only be dissolved by mutual agreement of all parties with judicial oversight. Your word is your bond creating duties, rights and obligations between parties.

Any 'contract' with PERSONS (strawman, legal fiction juristic person) is a **service agreement**, it is not as binding as a contract, especially when fraudulently (not all maxims) brought into being.

<u>Binding Precedence</u> Interactions with other people can result in dispute because of misunderstanding due to presumptions, assumptions, bad expression or no meeting of the minds. Where that is intentional it is fraudulent in that its knowingly causing harm (trespass). To resolve this both parties need public/social resolution through the courts. The claimant (victim) needs to prove the claim, defendant (respondent) is innocent until proven otherwise. The court will make a ruling and a precedence is created.

# **England's Constitutional structure**

Note: this is not the British or Scottish or Welsh as in the UK



If we look at our constitutional hierarchical structure, this is where you stand and how you interact with the elements of its structure.

Note: The Head of State is at the same level as The People

# Language

The 'spoken' word can be interpreted, misrepresented or taken out of context; it is the written word that is important.

The words you use and the context in which you use them is defined by your comprehension and knowledge of your status and not your education.

There can be two meanings to particular words. The English dictionary is what we would normally expect to find the meaning and syntax of a word, BUT, within civil proceedings and also legislation there are other sources for the intended meaning of a word when written (or spoken when used at a venue e.g., (Court). Within Civil proceedings the main one is Black's Law Dictionary (there are others). Within legislation there is the Interpretation Act, which applies to any legislation that is referenced to it but not all.

### Resolution not Revolution

Are you acting as one of **The People** or your **CAPITALISED** entity which is the lower than all others, or in other words servant or slave?

There are many and even more suggestions on how to resolve this deception that has be brought upon the people.

The gist of it, from my point of view, is to first recognise that everything, or truth, is subjective. It is dependent on the story that is being told and by who, who is sponsoring that story and what narrative fits into your comprehension and belief.

I will put forward my findings of the ones that have influenced me, the processes that I believe are the way to re-present you as you and not as a PERSON
